Beethoven, by Maynard Solomon. New York: Schirmer Books, 1977. Distributed in Canada by Collier-Macmillan. 400 pages. \$16.95.

As Maynard Solomon notes in his preface, Beethoven "had no fear that the assessment of his music would be adversely affected by a full knowledge of the facts of his life . . . [he] left as rich a mass of documentary material as any composer in history."

Sadly, however, Beethoven's early biographers, particularly Schlosser and Schindler, saw fit to freely elaborate on the primary documents, producing error-filled studies which led subsequent biographers astray, so that it became increasingly difficult to separate fact from fiction.

Even the renowned Thayer was misled by Schindler's account, and moreover, in his effort to achieve a definitive study, tended to fit the facts into a Procrustean Bed of logic which at least on one occasion (in the case of the Immortal Beloved riddle) was based on a desire to preserve the quality of Beethoven's character.

Solomon's biography is remarkable in both its faithfulness to the facts and

its patient unravelling of many of the most controversial areas of Beethoven's life. He has unearthed no new documents — rather he has resisted the impulse to stray from the existing ones — and has built a solid case of evidence to support his aesthetic, historical, psychological and sociological interpretations.

One of Solomon's most noted contributions to Beethoven scholarship was his identification "beyond a reasonable doubt" several years ago, of Antonie Brentano as Beethoven's Immortal Beloved. In a fascinating chapter he relates the step-by-step process of deductive reasoning based on existing facts that led him to his conclusion. The account — equal to the best of Sir Arthur Conan Doyle — reveals the painstaking thoroughness with which Solomon approaches his subject.

The author devotes a great deal of attention to a psychological portrait of Beethoven, zeroing in on a number of misconceptions which were perpetrated by the composer himself. Why, for example, did Beethoven insist that he was born in 1772 rather than in 1770, when all evidence supported the latter? (The myth was not, as previously

thought, nourished by his parents in an effort to increase their son's reputation as a prodigy.) Why did Beethoven refuse to dismiss contemporary rumors that he was, in fact, of noble birth, thereby casting doubts upon his mother's virtue? Why was he loathe to write his brother's name? Solomon's answer to these, and other puzzles, lies in a complex fantasy which Freud and Otto Rank called the "Family Romance", in which the child "replaces one or both parents with elevated surrogates". Solomon develops a highly convincing argument to support this theory, which in turn helps explain many inconsistencies in Beethoven's character and in particular, his violent love/hate relationship with his nephew Karl.


Other aspects of Beethoven's life which come under close psychological scrutiny are his relationships with women, his reluctance to engage in either public or private piano performances, his attitude towards his deafness, and his political vacillations.

Each of the four sections of the book ends with a chapter on Beethoven's music, which is discussed largely in terms of the composer's personal development. These are the weakest chapters, but nevertheless interesting, and the reader may refer to the comprehensive bibliographic essay (which, together with a complete index of Beethoven's compositions, closes the book) for more thorough musical analyses.


The publishers of **Beethoven** evidently were aware of the great importance this new biography is certain to have. It has been published with care on excellent quality paper and set in a gentle colour of brown ink, which will spare the eyes of many readers who will find themselves unable to put the book down until they have read the last page.

Ezra Pound and Music, ed. by R. Murray Schafer. New York: New Directions Publishing, 1977. Distributed in Canada by McClelland and Stewart Ltd. 530 pp. \$50.00.

Ezra Pound was one of the greatest poets of this century. For that reason alone this surprisingly thick volume of his collected musical writings should be of interest. But what makes it even more interesting is the fact that Pound was also a composer — strictly amateur, but nonetheless his "opera" *Villon* is one of the most astonishing works of the 1920s avant-garde. One recording of it exists, but it deserves to be better known. Furthermore, Pound wrote a short "Treatise on Harmony" which outlines a genuinely novel approach to theory. Composer R. Murray Schafer

(editor of this collection) affirms that "the total number of contributions to the science of harmony in our century is three," ranking Pound with Schönberg and Schenker.

Pound's involvement in the revival of early music and revolt against romanticism helped shape modern musical taste. He belongs in the select company of great authors who have contributed to music, along with Mann, Rolland, Shaw. Pound's reviews, especially those written under the name "William Atheling" can be appreciated for their sheer entertainment value, like those of Shaw. Pound has less rhetorical elegance than Shaw, but more bite. Of pianist Katherine Goodson, he comments, she "knows perfectly well what furious or noble emotions the composer intended to convey and strives with a sort of maidenly gallantry to convey them." He describes a particular vocalist's efforts as "the sort of singing called 'English' by hostile nations."

Readers will enjoy these reviews — especially upon discovering such gems as Pound's praise for an Artur Schnabel recital given 58 years ago. Pound devoted his most serious attention, however, to the composers. His remarks combine clear biases with smarting criticism of repertoire: Tchaikovsky, he says, "is not cheap all the time, or even, perhaps, most of the time, but he keeps one in a state of anxiety." He described one ensemble as having "opened the weeping camembert of Schubert's *Trio in B-flat*." Another "assailed the Dvorak, *A major*, op. 81, and rendered the popular, bouncing, prancing, and slightly bumptious exhilaration of the piece quite effectively . . . There is no desiccating intellectuality; no narrow appeal to the intelligensia; the music is a little incomplete without food."

But as Schafer's expert commentary demonstrates, Pound's powerful, if crotchety mind bears the most serious kind of reading. As a poet, he has much to say about music and words. His praise of Henry Lawes and William Young shows appreciation of a generation of English composers still unknown. He campaigned for the revival of medieval music when Dolmetsch was still considered a crank, and in 1935 he made practical contributions to the exhumation of Vivaldi's music.

Pound's taste alligns fairly well with Stravinsky's disinterest in the Viennese symphonic tradition, rejection of Wagner, suspicion of Debussy. But Pound's interest in George Antheil during the 1920s, with the resulting "Treatise on Harmony", shows one of the earliest responses to the futurist challenge of Luigi Russolo's art of noises — Pound attempting to restore music form to sounds conceived as pure *objets sonores*, and anticipating by 40 years

some of Stockhausen's efforts in the same direction. *Ezra Pound and Music* should establish Pound as one of our major music critics.

Evening at Symphony: A Portrait of the Boston Symphony Orchestra, by Janet Baker-Carr. Boston: Houghton Mifflin Co., 1977. 172 pages, \$14.95.

The Boston Symphony Orchestra is a remarkable institution and a very deserving subject for a book. It was founded in 1881 by Major Lee Higginson and sustained by him until he handed it over to a board of trustees in 1918. Brought up in the upper-class New England Puritan tradition, Higginson was a firm believer in hard work, rugged individualism and Beethoven. He wasn't rich enough to be considered a robber baron, but took all his responsibilities as a leading Boston merchant seriously, performing his charitable and patriarchal duties with enthusiasm. The Boston Symphony Orchestra remains to this day very much the creation of Major Higginson.

As most of us are probably aware, the history of the Boston Symphony Orchestra is a long and distinguished one. There are very few conductors or performers of note who have not

at some time been connected with the orchestra. Perhaps the most interesting phenomenon documented in this book is the change in the role of the conductor. While the job itself has remained essentially the same, the way conductors are perceived and perceive themselves has radically altered. Gone are the days when conductors ruled by divine right. The best (or worst) representative of this school was Serge Koussevitsky. He maintained that the orchestra members were not only children, but *his* children. Baker-Carr's book contains ample illustrations of the man's arrogance, jealousy and imperious attitudes. According to the author, "when musicians long since retired from the orchestra hear his voice on tape saying crisply, 'Gentlemen, it is very not together,' cold shivers still run down their spines."

Among the most curious episodes recorded in *Evening at Symphony* are those concerning various composers invited to conduct their own works with the Boston Symphony. The ever resplendent Ravel was one of them. In 1928, while rehearsing the orchestra, he intrigued its members by wearing a blue shirt and blue suspenders. For the next rehearsal he turned up in matching pink. Now honestly, what could be more interesting than that?

at some time been connected with the orchestra. Perhaps the most interesting phenomenon documented in this book is the change in the role of the conductor. While the job itself has remained essentially the same, the way conductors are perceived and perceive themselves has radically altered. Gone are the days when conductors ruled by divine right. The best (or worst) representative of this school was Serge Koussevitsky. He maintained that the orchestra members were not only children, but *his* children. Baker-Carr's book contains ample illustrations of the man's arrogance, jealousy and imperious attitudes. According to the author, "when musicians long since retired from the orchestra hear his voice on tape saying crisply, 'Gentlemen, it is very not together,' cold shivers still run down their spines."

Among the most curious episodes recorded in **Evening at Symphony** are those concerning various composers invited to conduct their own works with the Boston Symphony. The ever resplendent Ravel was one of them. In 1928, while rehearsing the orchestra, he intrigued its members by wearing a blue shirt and blue suspenders. For the next rehearsal he turned up in matching pink. Now honestly, what could be more interesting than that?
